**READY TO DO BIG, BOLD THINGS?**

\*To be a “qualified referral,” the merchant prospect must not be a current Worldpay from FIS customer or prospect in the referral system and must be willing to speak to a Merchant Services Account Representative. For the monthly rewards, your Referral Rewards Points will be awarded by the last day of the following month, at which time you will receive an email from Worldpay Referral Rewards <[info.worldpayreferralrewards@nxlperformance.com](mailto:info.worldpayreferralrewards@nxlperformance.com)>. A minimum of two qualified referrals per month is required. The initial two qualified referrals submitted during the calendar month and during the promotion period (1/1/23 -12/31/23) will be awarded 1,200 Referral Rewards Points. A bonus of 600 Referral Rewards Points will be awarded for every qualified referral after the first two within the calendar month. A banker earns an additional 2,400 rewards points only if they have referred at least one qualified referral every month consecutively for a quarter. Referral rewards points will be awarded by the last day of the following month in the next quarter: 4/30/23, 7/31/23, 10/31/23, and 1/31/2024. The consecutive referrals must be submitted three months in a row within a quarter and referral submissions cannot overlap quarters. The Worldpay Referral Rewards Program is applicable only to current financial institution employees who are employed by the financial institution at time of both referral and receipt of Referral Rewards Points. Consecutive referral offer ends 12/31/23. Additional terms and conditions may apply.
