




## The importance of working capital

In sponsor-backed businesses, every improvement in free cash flow directly supports debt reduction, reinvestment and a stronger exit multiple. Yet significant cash is often trapped in receivables processes, slow collections and inefficient financing structures.

Optimising working capital is one of the fastest, least dilutive ways to release that cash. By accelerating the cash conversion cycle and accessing alternative funding sources to improve working capital still further, portfolio companies can generate liquidity without increasing leverage – boosting both resilience and value creation.

Research by Alvarez & Marsal suggests that working capital improvement programmes routinely generate a one-time cash flow equivalent to 5-9% of revenue, resulting in a 10-30% higher Multiple on Invested Capital over the life cycle of a portfolio company investment.








