Payment details are contained within transaction message or reconciled to extended data message.

#### **Immediate Confirmation**

For each message, a systemic confirmation with payment status is provided within seconds. Confirmation is sent directly to the originator.

All RTP network transactions are credit only, final, and irrevocable.
